

ORDINANCE NO. 8081-97

AN ORDINANCE  
AMENDING CHAPTER 26, ENTITLED "VEHICLES FOR HIRE",  
OF THE CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,  
as follows:

Section 1. That the existing language of Section 26-83, entitled "Rates of fare - Generally", of Chapter 26, entitled "Vehicles for Hire", of the Code of Ordinances, City of Urbana, Illinois, is hereby repealed upon the taking effect of the first schedule filed with the City Clerk pursuant to the new Section A below, and in its place the following is enacted:

"A. Each person, firm, corporation or other business entity owning, operating or controlling taxicab service in the City of Urbana shall, before making any charge for service, file a schedule of rates with the City Clerk of the City of Urbana, Illinois. The City Clerk shall keep such schedule on file and available for public inspection, and shall promptly mail a copy of such schedule, and any new, modified or amended rate schedule when filed, to each member of the City Council. Failure to so mail such schedules, however, shall not affect the validity thereof. The said rates shall be uniform as to class of service. No charge for service shall be made by any said person, firm, corporation or other business entity, or agent of employee thereof, which is in excess of the rate shown for such service on the schedule so filed with the City Clerk. No new, modified or amended rate shall become effective, or any charge be made based thereon, unless or until a schedule setting forth such new, amended or modified rates have been on file with the City Clerk for forty (40) days. No new, amended or modified rates shall take effect if, within forty (40) days of filing such with the City Clerk, the City Council of the City of Urbana passes an ordinance disapproving the said modified rate schedule.

B. The schedule of fares which is then in effect shall be prominently posted in the passenger section of each vehicle licensed as a taxicab."

Section 2. That the existing language of Section 26-48, entitled "Identification card; badge", of Chapter 26, entitled "Vehicles for Hire", of the Code of Ordinances, City of Urbana, Illinois, is hereby repealed and in its place the following is enacted:

"(a) In addition to the license prescribed by Section 26-47 there shall be issued:

- (1) An identification card containing the driver's license number and which shall have the driver's photograph attached thereto; and
- (2) A driver's badge containing the driver's license number.

(b) The driver's badge shall always be worn on the front and outside of the driver's clothing, and shall be valid only during the term of the license of the driver to whom it is issued."

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 20th day of April, 1981.

ity thereof. The said rates shall be  
uniform as to class of service. No  
charge for service shall be made  
by any said person, firm, corpora-  
tion or other business entity, or  
agent of employee thereof, which  
is in excess of the rate shown for  
such service on the schedule so  
filed with the City Clerk. No new,  
modified or amended rate shall  
become effective, or any charge be  
made based thereon, unless or  
until a schedule setting forth such  
new, amended or modified rates  
have been on file with the City  
Clerk for forty (40) days. No new,  
amended or modified rates shall  
take effect if, within forty (40)  
days of filing such with the City  
Clerk, the City Council of the City  
of Urbana passes an ordinance  
disapproving the said modified  
rate schedule.

B. The schedule of fares which is  
then in effect shall be prominently  
posted in the passenger section of  
each vehicle licensed as a  
taxicab."

Section 2. That the existing language  
of Section 26-48, entitled "Identification
