ORDINANCE NO. 8182-13

AN ORDINANCE ESTABLISHING THE PENALTY FOR A VIOLATION OF A PORTION OF THE URBANA ZONING ORDINANCE (UNAPPROVED PARKING AREAS)

WHEREAS, in Ordinance 8182-12, the offense of parking in unapproved parking areas is created; and

WHEREAS, in Section XI-9 of the Zoning Ordinance, it is provided that the fine for violation of Section VIII-3.5 of the Zoning Ordinance shall be as determined from time to time by the City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE URBANA CITY COUNCIL that:

Section 1. Every person who violates Section VIII-3.5 of the Urbana Zoning Ordinance may within twenty-four (24) hours of the time when the citation referred to in Section XI-la was placed upon the vehicle found in violation of Section VIII-3.5, pay as the penalty for, and in full satisfaction of such violation, the sum of Fifteen Dollars (\$15.00), and within the next seventy-two (72) hours the sum of Twenty-five Dollars (\$25.00). The failure of such person to make such payment within seventy-two (72) hours shalk render such person subject to a fine not less than Twenty-five Dollars (\$25.00) and not more than Two Hundred Dollars (\$200.00).

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 17th day of August, 1981.
