AN ORDINANCE
FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE FISCAL YEAR BEGINNING JULY 1, 1981 AND ENDING JUNE 30, 1982 , IN AND FOR THE CITY OF URBANA SPECIAL SERVICE AREA NUMBER TWO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. Findings. The City of Urbana Special Service Area Number Two has been created by an Ordinance, entitled "An Ordinance Establishing City of Urbana Special Service Area Number Two", adopted September 7, 1976, approved September 8, 1976, and effective as of September 8, 1976, and no petition has been filed opposing the creation of the special service area pursuant to Chapter 120 , Illinois Revised Statutes, Section 1309 . Said Special Service Area Number Two consists of the territory described in the Ordinance aforesaid, which such territory is also more particularly described in Attachment "A" to this Ordinance and depicted on Attachment "B" of this Ordinance. The City of Urbana is now authorized to levy taxes for special services in said Special Service Area Number Two.

Section 2. That the total amount of budgeted
appropriations for all purposes to be collected from the tax levy of the current fiscal year in Special Service Area Number Two is ascertained to be the sum of $\$ 16,400.00$.

Section 3. That the following sum be, and the same hereby is, levied upon the taxable property, as defined in the Revenue Act of 1939, in the City of Urbana Special Service Area

Number Two, said tax to be levied for the fiscal year beginning July 1, 1981 and ending June 30, 1982:

Section 4. That the sum of $\$ 15,000.00$ of the $\$ 16,400.00$ sum heretofore authorized to be levied under this Ordinance for the fiscal year beginning July 1,1981 and ending June 30, 1982, is further ascertained to be the sum and amount attributable to the following specific portion of the taxable property, as defined in the Revenue Act of 1939, in Special Service Area Number Two, which such taxable property consists of the following described territory and is depicted and listed in Attachment "C" to this Ordinance:

The South 360 feet of the West 390 feet of the Southeast Quarter of Section 16, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois; and all real estate located South of the South line of said Section 16, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois, except the North 190 feet of the East 190 feet of the Northeast Quarter of the Northwest Quarter of Section 21, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois;
and that said sum of $\$ 15,000.00$ be and the same is hereby abated for the fiscal year beginning July 1,1981 and ending June 30, 1982, the City of Urbana having previously received payment from the property owners of such specific portion of the taxable property as defined in the Revenue Act of 1939 in Special Service Area

Number Two in accordance with an agreement between the City of Urbana and such property owners dated the 9th day of April, 1979, which such agreement was approved by the Circuit Court, Champaign County, Illinois, in Docket Numbers 76-C-1045 and 77-C-156. The County Clerk of Champaign County, Illinois is accordingly directed to extend no taxes for collection on the tax books for the purpose of raising revenues to pay appropriations in Special Service Area Number Two for the fiscal year beginning July 1,1981 , and ending June 30 , 1982, upon such specific portion of the taxable property more particularly described in this section, and as defined in the Revenue Act of 1939, in Special Service Area Number Two. Section 5. That the sum of $\$ 1,400.00$ of the $\$ 16,400.00$ sum heretofore authorized to be levied under this Ordinance for the fiscal year beginning July l, 1981 and ending June 30, 1982, is further ascertained to be the sum and amount attributable to the rest and remainder of the taxable property, as defined in the Revenue Act of 1939 and not otherwise described in Section 4 of this Ordinance but which is further depicted and listed on Attachment "C" in Special Service Area Number Two for the fiscal year beginning July l, 1981 and ending June 30, 1982.

Section 6. This tax is levied pursuant to Article VII, Sections 6 A and 6 L of the Constitution of the State of Illinois and Chapter 120, Illinois Revised Statutes, Section 1301 et seq. and pursuant to An Ordinance Establishing the City of Urbana Special Service Area Number Two.

Section 7. That there is hereby certified to the County Clerk of Champaign County, Illinois, the sum of $\$ 1,400.00$ constituting the total amount of tax the City of Urban Special Service Area Number Two requires to be raised by taxation for the current fiscal year of said City, said sum of $\$ 1,400.00$ to be levied upon the rest and remainder of the taxable property, as defined in the Revenue Act of 1939 and not otherwise described in Section 4 of this Ordinance but which is further depicted and listed on Attachment "C" hereto, in City of Urban Special Service Area Number Two for which no abatement is herein provided, and the City Clerk of the City of Urban is hereby ordered and directed to file with the County Clerk of Champaign County, Illinois, on or before the time required by law a certified copy of this Ordinance.

Section 8. This Ordinance shall be in full force and effect from and after its adoption, approval and publication as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urban, Illinois, at Garegutar meeting of said Council on the 24 th day of
