ORDINANCE NO. 8182-34

AN ORDINANCE VACATING A PORTION OF UNIVERSITY AVENUE

WHEREAS, the City of Urbana, Illinois, has on its own Petition, determined to vacate a portion of the City Right-Of-Way known as University Avenue, located between Orchard Street and Coler Avenue; and

WHEREAS, the City Council of the City of Urbana, Illinois, has determined that the public interest will be subserved by vacating those properties described herein.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Illinois, as follows:

Section 1. That the City Council of the City of Urbana, Illinois, hereby vacates, subject to the terms set forth in this Ordinance, the property described as follows:

All that portion of University Avenue which lies between the East Right-Of-Way line extended from the North side of University Avenue of Coler Avenue and the West Right-Of-Way line extended from the North side of University Avenue of Orchard Street, except that part thereof that is located within 33' 10 1/2" North of the centerline of said University Avenue and within 35' 4 1/2" South of the centerline of said University Avenue and within 2' 5 1/4" below the highest point located on the centerline of said University Avenue and 19' 8 3/4" above the highest point located on the centerline of said street, all located between Orchard Street and Coler Avenue in the City of Urbana, County of Champaign, Illinois, more specifically identified by mean sea level measurements as indicated on the permit drawings submitted to the City of Urbana on December 4, 1979, and May 5, 1980.

Section 2. The City of Urbana, Illinois, hereby reserves easements upon and under said portions of said street, for the maintenance and repair of all sewers and drains and all public service facilities which are located on or under the surface of any part of said portion of said street, and a surface easement for pedestrian sidewalks on that portion of said street located within 33' 10 1/2" North of the centerline and 35' 4 1/2" South of the centerline of said University Avenue.

Section 3. The vesting of title in the portions of said street hereby vacated shall be subject to any existing easement or easements for public utilities, their successors and assigns, to operate, maintain, renew and reconstruct their facilities, and as are now operated and maintained in, over or under any portions of said street so vacated, the corporate authorities having determined that it is both necessary and desirable for the public interests that the public services of all of said public utilities be able to be continued by the means of said facilities.

Section 4. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called and entered on the records of this corporate authority, by three-fourths vote of the aldermen and alderwomen holding office who did not abstain from voting on this Ordinance, all in accordance with the Ordinance No. 7374-61 of the City of Urbana, Illinois, heretofore adopted and in effect.
