RADIO BID SPECS

Requirements for Submission of Bid:

- 1. All mobile units (8) will be sold as a group.
- 2. All portable units (7) will be sold as a group.
- 3. All bids must be accompanied by a certified check in the amount of 10% of the total bid made payable to the City of Urbana.
- 4. Payment in full must be made when picking up the radios or within 30 days, whichever occurs first.
- 5. If the successful bidder does not have an FCC license for the frequencies currently in the radios, the crystals will be removed before delivery.
- 6. Radios are complete except for antennae and maintenance manuals.
- 7. All radios were in working order as of 10-4-81 except the General Electric Pocket Mate portables whose present condition is unknown.
- 8. The successful bidder must pick up the radios within 30 days of bid award.
- 9. Bid price will be FOB Urbana, Illinois. Any shipping charges must be paid by the successful bidder.
- 10. The City of Urbana reserves the right to refuse any or all bids.
