

ORDINANCE NO. 8182-52

AN ORDINANCE  
IN RELATION TO MUNICIPAL  
AUTOMOBILE RENTING OCCUPATION TAX ACT

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS, as follows:

Section 1. A tax is hereby imposed upon all persons engaged in the business of renting automobiles in the City of Urbana at the rate of one percent (1%) of the gross receipts from such rentals made in the course of such business while this Ordinance is in effect, in accordance with the provisions of Section 8-11-7 of the Illinois Municipal Code.

Section 2. Every such person engaged in such business in the City of Urbana shall file on or before the last day of each calendar month, the report to the Illinois Department of Revenue required by Sections Two and Three of "An Act in Relation to a Tax upon Persons Engaged in the Business of Selling Tangible Personal Property to Purchasers for Use or Consumption" approved June 29, 1933, as amended.

Section 3. At the time such report is filed, there shall be paid to the Illinois Department of Revenue the amount of tax hereby imposed on account of the renting of automobiles during the preceding month.

Section 4. The City Clerk is hereby directed to transmit to the Illinois Department of Revenue a certified copy of this Ordinance not later than five (5) days after the effective date of this Ordinance.

Section 5. This Ordinance shall be effective on the first day of the calendar month next following publication as provided in Section 1-2-4 of the Illinois Municipal Code. Certified proof of publication shall be forwarded to the Illinois Department of Revenue along with the certified copy of this Ordinance as required by Section 4.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois at a regular meeting of said Council on the 18th day of January, 1982.

Section 3. At the time such report  
is filed, there shall be paid to the  
Illinois Department of Revenue the  
amount of tax hereby imposed on  
account of the renting of automobiles  
during the preceding month.

Section 4. The City Clerk is hereby  
directed to transmit to the Illinois  
Department of Revenue a certified  
copy of this Ordinance not later than  
five (5) days after the effective date  
of this Ordinance.

Section 5. This Ordinance shall be  
effective on the first day of the  
calendar month next following publi-  
cation as provided in Section 1-2-4 of  
the Illinois Municipal Code. Certified  
proof of publication shall be for-  
warded to the Illinois Department of  
Revenue along with the certified  
copy of this Ordinance as required  
by Section 4.
