## AN ORDINANCE APPROVING PRELIMINARY AND FINAL PLATS

WHEREAS, the Preliminary and Final Plats of the First
Plat of Sunnycrest Corporation Subdivision are in compliance with
the pertinent ordinances of the City of Urbana, Illinois; and

WHEREAS, the City Engineer has reviewed and approved the Engineering Plans and Specifications for the First Plat of the Sunnycrest Corporation Subdivision; and

WHEREAS, in Case No. 1125-S-82, the Urbana Plan Commission has recommended approval of the Final Plat of the First Plat of Sunnycrest Corporation Subdivision.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

- 1. The Final Subdivision Plat of the First Plat of Sunnycrest Corporation Subdivision, as filed herein, is approved.
- 2. The City Clerk is, however, directed not to affix her signature to the said Plat unless and until the developer:
  - a) submits an Offsite Sanitary Sewer Easement in good and sufficient form to the City Engineer, and such Easement is accepted by the City Engineer; and
  - b) has caused the completion and acceptance by the City of all sewer work or submits good and sufficient bond to guarantee the installation of such sewer work.

Dear Mr. Kindra:

We have been watching the construction of the sanitary sewer to serve the three (3) lots in Sunnycrest Corporation Subdivision lying east of Cottage Grove Avenue and north of Colorado Avenue this past few days. The major portion of the construction we estimate will be completed by noon this date, May 3, 1982.

There will be some minor work to be done after that time, which includes adjusting the manhole frames and grates to grade and, of course, the testing of the sewer for leaks. 
