

ORDINANCE NO. 8182-68

AN ORDINANCE
AMENDING ORDINANCE NO. 8081-118,
ENTITLED, "AN ORDINANCE ESTABLISHING A REFUND
VALUE FOR CERTAIN BEVERAGE CONTAINERS"

WHEREAS, Ordinance No. 8081-118, entitled, "An Ordinance Establishing A Refund Value For Certain Beverage Containers", was passed by the City Council on the 18th day of May, 1981, and, upon reconsideration following a mayoral veto, was again passed by two-thirds of the aldermen/alderwomen then holding office on the 1st day of June, 1981; and

WHEREAS, said Ordinance was duly caused to be published by the City Clerk of the City of Urbana in the Champaign-Urbana News-Gazette on the 16th day of June, 1981, in accordance with law; and

WHEREAS, Section 8 of the said Ordinance provided as follows:

Section 8. Effective Date.

This Ordinance shall be in full force and effect twelve (12) months after its passage and publication as required by law, or twelve (12) months after the passage and publication as required by law of a similar ordinance duly passed and adopted by the City of Champaign, Champaign County, Illinois, whichever is the later date, and shall apply to all beverage containers sold or offered for sale after that date;

and

WHEREAS, the City Council of the City of Champaign duly passed and adopted Council Bill 79-97, entitled, "An Ordinance Establishing A Refund Value For Certain Beverage Containers", on April 17, 1979, which such Ordinance was duly published according to law, and which such Ordinance was similar to said Ordinance No. 8081-118 referred to herein; and

WHEREAS, the City Council of the City of Champaign duly passed and adopted Council Bill 81-108, entitled, "An Ordinance Repealing An Ordinance Establishing a Refund Value For Certain Beverage Containers", on June 2, 1981, which such Ordinance repealed in its entirety Council Bill 79-97 before its effective date; and

WHEREAS, it was and remains the intent of this City Council that the said Ordinance No. 8081-118, if it is to become effective at all, should be effective in both the City of Champaign, Illinois and the City of Urbana, Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

That Section 8, entitled, "Effective Date", of the said Ordinance No. 8081-118, be and the same is hereby amended to read as follows:

Section 8. Effective Date.

Provided that a similar Ordinance is duly passed and adopted by the City Council of the City of Champaign, Champaign County, Illinois and that such Ordinance remains in effect, this Ordinance shall be in full force and effect twelve (12) months after the publication as required by law of such a similar Ordinance duly passed and adopted by the City Council of the City of Champaign, Champaign County, Illinois.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the City Council of the City of Urbana, Illinois at a regular meeting of said Council on the 5th day of April, 1982.
