

ORDINANCE NO. 8182-79

AN ORDINANCE
AMENDING SECTION 24-36, ENTITLED,
"USE OF PUBLIC SEWERS REQUIRED", OF THE CODE
OF ORDINANCES, CITY OF URBANA, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
URBANA, ILLINOIS, as follows:

1. That Section 24-36, entitled, "Use of public sewers required", of Chapter 24, entitled, "Utilities", of the Code of Ordinances, City of Urbana, Illinois, is hereby amended by adding subsections (e) and (f) thereto as follows:

(e) The owners of all houses, buildings, or properties used for human occupancy, employment, recreation or other purposes, situated within the city which are connected to a public sanitary sewer in the city which is to be abandoned as a public sanitary sewer and replaced by a new public sanitary sewer, are hereby required at their expense to disconnect their sanitary facilities and drains from the sewer to be abandoned and connect those sanitary facilities and drains to the approved new public sanitary sewer in accordance with the provisions of this division within ninety days of official notice by the City Engineer to do so. Permit fees for the work necessitated by this change of connection will be waived.

(f) When it is determined by the City Engineer that the sanitary facilities and drains for a house, building, or property used for human occupancy, employment, recreating or other purposes, situated within the city, is not connected to the proper public sanitary sewer that serves the property, (i.e., the sanitary sewer that the property fronts on) the owner(s) of that property are hereby required at their expense to connect their sanitary facilities and drains to the proper sanitary sewer in accordance with the provisions of this division within ninety days of official notice by the City Engineer to do so.

2. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 17th day of May, 1982.

adding subsections (3) and (f)
thereto as follows:

(e) The owners of all houses,
buildings, or properties used for
human occupancy, employment,
recreation or other purposes,
situated within the city which are
connected to a public sanitary
sewer in the city which is to be
abandoned as a public sanitary
sewer and replaced by a new pub-
lic sanitary sewer, are hereby re-
quired at their expense to discon-
nect their sanitary facilities and
drains from the sewer to be aban-
doned and connect those sanitary
facilities and drains to the ap-
proved new public sanitary sewer
in accordance with the provisions
of this division within ninety days
of official notice by the City En-
gineer to do so. Permit fees for the
work necessitated by this change
of connection will be waived.

(f) When it is determined by the
City Engineer that the sanitary fa-
cilities and drains for a house,
building, or property used for
human occupancy, employment,
recreating or other purposes,
situated within the city, is not con-
nected to the proper public sani-
tary sewer that serves the property,
(i.e., the sanitary sewer that the
property fronts on) the owner(s) of
that property are hereby required
at their expense to connect their
sanitary facilities and drains to the
proper sanitary sewer in accor-
dance with the provisions of this
division within ninety days of offi-
cial notice by the City Engineer to
do so.

2. This Ordinance shall be in full
force and effect from and after its
passage and publication in accor-
dance with the terms of Section 1-2-4
of the Illinois Municipal Code.

This Ordinance is hereby passed
by the affirmative vote, the "ayes"
and "nays" being called, of a major-
ity of the members of the Council of
the City of Urbana, Illinois, at a reg-
ular meeting of said Council on the
17th day of May, 1982.
