

ORDINANCE NO. 8182-80

AN ORDINANCE
AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
URBANA, ILLINOIS, as follows:

Section 1. That Schedule VII, entitled "Stop Signs,"
of Section 8-3, of Article VIII, of the Urbana Local Traffic
Ordinance, as amended, be and the same is hereby further amended
by adding to that schedule the following intersections where
drivers of vehicles shall be required to stop before entering
the intersection:

Washington	Eastbound at Birch
Washington	Westbound at Birch
Washington	Eastbound at Orchard
Washington	Westbound at Orchard

Section 2. That the City Traffic Engineer, pursuant
to Section 4-8, entitled "City Traffic Engineer to designate
crosswalks and establish safety zones," of Article IV, entitled
"Traffic-Control Devices," of the Urbana Local Traffic Ordinance,
as amended, be and the same is hereby authorized and directed to
establish Washington Street, between Race Street and Busey Avenue,
as a safety zone where children are at play and to place such
appropriate official traffic-control signs as are deemed necessary
on the said portion of Washington Street to carry out the provisions
of this section.

Section 3. This Ordinance shall be in full force and
effect from and after its passage and publication in accordance
with the terms of Section 1-2-4 of the Illinois Municipal Code,
and shall be and remain in full force and effect for one year
after said date. The provisions of this Ordinance shall be placed

on the agenda of the Traffic Commission in April, 1983, at which such time said Traffic Commission shall review the same and make such further recommendations to the City Council as it deems appropriate for any modification or continuation thereof.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 7th day of June, 1982.

safety zones," of Article IV, entitled
"Traffic-Control Devices," of the
Urbana Local Traffic Ordinance, as
amended, be and the same is hereby
authorized and directed to establish
Washington Street, between Race
Street and Bussey Avenue, as a safety
zone where children are at play and
to place such appropriate official
traffic-control signs as are deemed
necessary on the said portion of
Washington Street to carry out the
provisions of this section.

Section 3. This Ordinance shall be
in full force and effect from and
after its passage and publication in
accordance with the terms of Section
1-2-4 of the Illinois Municipal Code,
and shall be and remain in full force
and effect for one year after said
date. The provisions of this Ordina-
nce shall be placed on the agenda
of the Traffic Commission in April,
1983, at which such time said Traffic
Commission shall review the same
and make such further recom-
mendations to the City Council as it
deems appropriate for any modifica-
tion or continuation thereof.

This Ordinance is hereby passed
by the affirmative vote, the "ayes"
and "nays" being called, of a majori-
ty of the members of the Council of
the City of Urbana, Illinois, at a reg-
ular meeting of said Council on the
7th day of June, 1982.
