ORDINANCE NO. 8283-11

AN ORDINANCE NOLUMO N. 644 LEVYING A TAX FOR THE URBANA FREE LIBRARY FUNDOUNTY CLERK

WHEREAS, Section 3-1 of "An Act in Relation to Free Public Libraries for Cities, Villages, Incorporated Towns and Townships and to Repeal Acts and Parts of Act Therein Named," approved July 12, 1965, as subsequently amended, (Ill.Rev.Stats. Ch. 81, § 3-1, hereinafter "Local Library Act") provides that the corporate authorities shall levy a tax for library purposes, which such levy, pursuant to Section 3-5 of said Local Library Act, shall be in the amounts determined by the Board of Library Directors; and

WHEREAS, the Board of Library Directors has duly determined that the amount of Five Hundred Seventy Thousand Dollars (\$570,000) is the amount necessary to be levied by the corporate authorities of the City of Urbana for the Urbana Free Library Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the total amount of appropriations for the City of Urbana Illinois Free Library Fund legally made to be collected from the tax levy of the current fiscal year of the City of Urbana, is hereby ascertained to be the sum of Five Hundred Seventy Thousand Dollars (\$570,000).

That the sum of Five Hundred Seventy Thou-Section 2. sand Dollars (\$570,000) being the total appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the City of Urbana for the Urbana Free Library Fund, be and the same is hereby levied upon all of the taxable property in the City of Urbana, Illinois, subject to taxation in the current fiscal year, as such property is equalized and assessed for state and county purposes, said sum is being levied and assessed for the purpose of maintaining and operating the Urbana Free Library and Reading Room pursuant to the Local Library Act. The specific amounts as levied for the Urbana Free Library Fund are separately included herein by being placed in a separate column under the heading "To Be Raised By Tax Levy" which appears over the same, the tax so levied for the current fiscal year of the City of Urbana and for the said budgeted appropriations to be collected from said tax levy, the total of which has been ascertained as aforesaid for the particular purposes as follows:

Section 3. This Ordinance levying a tax for the Urbana Free Library Fund is adopted pursuant to the procedures set forth in the Local Library Act; provided, however, that any tax rate limitation or any other substantive limitations as to tax levies in the Local Library Act in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Section 6 of Article VII of the Constitution of the State of Illinois.

Section 4. There is hereby certified to the County Clerk of Champaign County, Illinois, the several sums aforesaid, constituting said total maximum amount of Five Hundred Seventy Thousand Dollars (\$570,000), which said total amount the City of Urbana requires to be raised by taxation for the current fiscal year of the City for the Urbana Free Library Fund, and the City Clerk of the City of Urbana is hereby ordered and directed to file with the County Clerk of Champaign County on or before the time required by law a certified copy of this Ordinance.

Section 5. If any provisions of this Ordinance or the application of such provision to any circumstances is held invalid for any reason whatsoever, the remainder of this Ordinance or the application of the provision to other circumstances shall not be affected thereby.

Section 6. This Ordinance shall take effect and be in full force and effect immediately on and after its approval.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
