ORDINANCE NO. 8283-16

AN ORDINANCE GRANTING A SPECIAL USE PERMIT (UNIVERSITY CHURCH OF GOD IN CHRIST)

WHEREAS, in Plan Case No. 1118-SU-81, the Petitioner requested a Special Use Permit to allow occupancy of an existing building by the University Church of God in Christ; and

WHEREAS, in Ordinance No. 8081-128, a Special Use Permit was granted for one year; and

WHEREAS, the Petitioner has requested that another Special Use Permit be issued respecting the same building in Plan Commission Case No. 1135-SU-82; and

WHEREAS, after due notice, a public hearing was held by the Urbana Plan Commission on July 22, 1982; and

WHEREAS, the said Urbana Plan Commission has recommended that a Special Use Permit be granted under certain conditions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1: That the University Church of God in Christ is hereby granted a Special Use Permit for the use of the existing building located at 1306 West Hill Street, Urbana, Illinois, for religious purposes for the said congregation.

Section 2: The said Special Use Permit, however, is expressly subject to the following conditions:

- a) That the occupancy load of the building be limited to 40 people;
- b) That the governing body of the University Church of God in Christ shall comply with the provisions of Section 16-2 of the Code of Ordinances of the City of Urbana (Noise Ordinance); and
- c) That all building code violations respecting the existing structure as set forth in a memorandum of Tom Ewers, dated July 13, 1982, be corrected within sixty (60) days after the Special Use Permit is issued hereunder. Upon failure to make such corrections within such time, the Special Use Permit issued hereunder shall automatically lapse.

Section 3. That the following requirements of Section VII-6 I. of the Urbana Zoning Ordinance are hereby waived:

- Minimum lot size of one (1) acre;
- Enclosure by a wire mesh fence of no less than six feet (6') in height; and
- Side and rear yards of twenty-five feet (25').

Section 4. The Zoning Administrator is authorized and directed to issue a Special Use Permit in compliance herewith.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, regular meeting of said Council.

Based on our June 24, 1982 inspection of 1306 W. Hill, we find that the following code items must be completed before this office may issue a final Certificate of Occupancy:

- 1) Remove projecting sign. (Urbana Zoning Ordinance, Table IX-3)
- 2) Remove bars, bolts, and double cylinder locks from all exit doors. Exit doors must always be readily openable from the inside without the use of a key. (1976 NFPA 101 Life Safety Code, Section 5-2.1.2.1.1)
- 3) Maintain at least 30" wide aisles. (NFPA, Section 8-2.5.3)
- 4) Exit doors must swing out. (NFPA, Section 5-2.1.1.4.4)
- 5) Hot water heater/stove area must be enclosed with one hour fire-rated construction and any doors must be self-closing solid wood or metal doors.

 Also, suspended heater must be enclosed or relocated. (NFPA, Section 6-5.1)
- 6) Install a wall-mounted 2A 20BC fire extinguisher. (NFPA, Section 6-4.4, as amended)
- 7) Remove curtain separating church from kitchen. If a wall and door are placed there instead, the door should swing into the kitchen and have an exit light on the church side. (NFPA, Section 17-1.2.1.1)
- 8) Provide 1½ hour fire-rated ceiling (firecode drywall) over church and kitchen. (1975 BOCA Basic Building Code, Table 902)
- 9) Provide proper trap and vent for kitchen sink. (1976 Illinois State Plumbing Code, Section 5.3.6)

Some of these items were required earlier, however Mr. Wittbrodt explained that the church was unwilling to spend money for corrections until they knew their use would be approved.

Please ensure that these requirements are made conditions of any final special use permit. If you desire, I will also send a copy of these requirements to Mr. Wittbrodt and the church.
