WHEREAS, in Ordinance No. 8182-78, the Urbana City Council amended standards relating to health, safety and welfare for mobile home parks situated in the City of Urbana; and

WHEREAS, it is determined to be in the best interest of the citizens of the City of Urbana that the existing amortization schedule regarding density in mobile home parks which contain more than five (5) mobile homes be amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

That Section VII-4, D., 2., of the Amended Zoning Ordinance of 1979 is hereby repealed.
