Section 1. That part (10), entitled "Food delivery vehicle & mobile food dispenser", under "Food Handling and Preparation", be and the same is hereby amended to read as follows:

- (10) Mobile food delivery and food dispensing vehicles:
  - a. Owners, per motorized vehicle . . . \$25.00
  - b. Owners, per nonmotorized vehicle. . . \$ 5.00

Section 2. That a new part (7) to be entitled "Amusement devices," under "Miscellaneous" be added thereto to read as follows:

- (7) Amusement devices:
  - a. For each amusement device . . . . . \$30.00b. For gamerooms . . . . . . . . . . . . . \$600.00
