BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

That Section 14-7, entitled "Schedule of fees," of the Code of Ordinances, City of Urbana, Illinois, be and the same is hereby amended in the following respects:

That part (2), entitled "Solicitors", under "Miscellaneous", be and the same is hereby amended to read as follows:

(2) Solicitors. Transient merchants, itinerant merchants, itinerant vendors, peddlers, canvassers, and solicitors (per year).

- a. License (per year). . . . . \$20.00
- b. Duplicate license (per year). . . . . \$ 5.00

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
