That part (2) of subsection (f), entitled "Billing", of Section 24-16, entitled "Sewer use charges", of the Code of Ordinances, City of Urbana, Illinois, be and the same is hereby amended to read as follows:

Charges set forth herein for all units shall be computed and billed semiannually and shall be due and payable within thirty (30) days from the statement date. In the event the statement of charges remains unpaid after thirty (30) days from the statement date, said charges shall then be delinquent and there shall be added thereto a late penalty in the amount of ten (10) percent of the amount of such bills for which payment remains delinquent and outstanding and interest shall be charged at the rate of one (1) percent per month or part thereof on any amount which remains delinquent and outstanding.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
