WHEREAS, the Urbana Plan Commission has recommended the adoption of the following changes to the text of the Zoning Ordinance of the City of Urbana, Illinois.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the following language be added to subsection D of Section VI-3, entitled "Lot Area and Width", of the Urbana Zoning Ordinance:

A fee simple transfer of ownership of a portion of a lot improved with a side by side duplex structure, where clearly each dwelling unit can be allocated to a portion of the single buildable lot, is permitted.

Such fee simple transfer of ownership of a portion of the buildable lot improved with a duplex unit does not constitute subdivision of the lot which shall remain as one lot for the application of development regulations contained in the Zoning Ordinance.

Section 2. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council on the Tto day of March, 1983.
