NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the following amendments to Section V-2, entitled "Principal and Accessory Uses", of the Urbana Zoning Ordinance are hereby enacted:

A. the existing subsection C.4 is amended to read as follows:

"It is not prohibited by other City Ordinances.";

- B. the word "and" should be deleted from the end of subsection C.5; and
- C. a new subsection C.7 is hereby added to read as follows:

"If such accessory building is to be located on a lot containing a single or two family dwelling, the area of the building shall not be greater than 750 square feet, regardless of zoning district."

Section 2. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.
