

ORDINANCE NO. 8283-55

AN ORDINANCE
AMENDING CERTAIN PROVISIONS OF SECTION 2-99
OF THE CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS

WHEREAS, budgetary constraints in recent years have required the City of Urbana to itself undertake certain construction and maintenance projects requiring skilled labor in order to reduce the costs of such projects which were previously accomplished by contracts between the City and third parties; and

WHEREAS, budgetary constraints in recent years have also placed the City in a position of having to rely on the use of special funds for general operating purposes in order for the City to itself undertake additional special projects requiring skilled labor; and

WHEREAS, the skilled labor for such construction, maintenance and special projects is seasonal in nature such that the employees required for such positions are only needed for an entire construction season but are not otherwise needed on a full-time basis; and

WHEREAS, the City of Urbana, operating under its home rule powers, now desires to make provision for the hiring of such seasonal employees for a period not to exceed two hundred forty (240) days in any calendar year without requiring such employees to be included in the classified civil service of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

That part (1) under subsection (a) of Section 2-99, entitled "Civil service system", of the Code of Ordinances, City of Urbana, Illinois, be and the same is hereby amended to provide as follows:

Officers who are elected by the people, or who are elected by the corporate authorities pursuant to ordinance or law, or whose appointment is subject to confirmation by the corporate authorities, judges of election, heads of any department or division of the city, members of the law departments, police cadets, a health officer appointed after July 1, 1953, seasonal employees, which means those persons whose employment does not exceed two hundred forty (240) days in any calendar year, one private secretary of each elected city

official, and administrative assistants to the mayor, administrative officer, chief librarian, or any other head of any department or division of the city, all part-time employees, which means those persons who work thirty-five (35) hours or less where the standard work week is forty (40) hours or more per week, city engineers, city building, plumbing or electrical inspectors, and those employees whose compensation is paid in whole or in part with funds provided by the state or the federal government, shall not be included in such classified service.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
