THEREFORE, BE IT ORDAINED by the Urbana City Council that:

The boundaries of the overlay zone known as Urbana Business

Development and Redevelopment District is hereby amended to include the following areas contiguous to the existing District:

- 1. Beginning at the middle of the intersection of Broad Alley and California Avenue, North to the intersection of Broad Alley and Main Street, East along the centerline of Main Street to the middle of the intersection of Main Street and Grove Street, South to the middle of the intersection of Grove Street and Fish Alley, West to the middle of the intersection of Fish Alley and Urbana Avenue, South to the middle of the intersection of Urbana Avenue and California Avenue, West to the place of beginning.
- 2. Beginning at the middle of the intersection of Springfield Avenue and Birch Street, North to the middle of the intersection of Birch Street (extended) and Main Street, Southeast along the centerline of Main Street to the middle of the intersection of Main Street and Central Avenue, North to the middle of the intersection of Central Avenue and Locust Street, East to the middle of the intersection of Locust Street (extended) and Cherry Alley (extended), South to the middle of the intersection of Cherry Alley (extended), and Main Street/Springfield Avenue, West along Springfield Avenue to the place of beginning.
- 3. Beginning at the middle of the intersection of Locust Street (extended) east and Cherry Alley (extended), North to the middle of the intersection of Cherry Alley (extended) and University Avenue, East along the centerline of University Avenue to the middle of the intersection of University Avenue and Maple Street, South along the centerline of Maple Street to the middle of the intersection of Maple Street and Main Street, West to the intersection of the

vacated N & W Railroad ROW, West along the centerline of the vacated N & W ROW to the middle of the intersection of the vacated N & W ROW and Race Street, South to the middle of the intersection of Race Street and Water Street, West to the place of beginning.
