Lots 529 and 530 of Ennis Ridge 6th Subdivision to the City of Urbana, situated in Champaign County, Illinois,

generally located between Harding and Brighton Drive, Urbana, Illinois.

Lot 529 bears the permanent index number 93-21-21-177-008; Lot 530 bears the permanent index number 93-21-21-177-016.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.


