

ORDINANCE NO. 8384-23

AN ORDINANCE
AUTHORIZING THE SALE OF VARIOUS
AND MISCELLANEOUS ITEMS OF PERSONAL
PROPERTY OWNED BY THE CITY OF URBANA, ILLINOIS

WHEREAS, the City of Urbana, Illinois, owns the items of personal property described on the attached list, which said items have been determined to be of no further use to the City of Urbana, Illinois, by the various department heads previously utilizing such items; and

WHEREAS, the City Council finds that those items on the attached list are no longer necessary or useful to, or for the best interests of the City of Urbana to retain.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the following items described on the attached list shall be offered for sale to the highest bidder at the next regular auction of items of personal property conducted by the City of Urbana: Vehicle Nos. PD11, MP75 and CD1.

Section 2. That the following items described on the attached list shall be offered for sale to the highest bidder by a process involving sealed bids, which such bids may be rejected by the Director of Public Works, or the designee thereof, in which such event such items shall be offered for sale to the highest bidder at the next regular auction of items of personal property conducted by the City of Urbana: Vehicle Nos. PW1, PD2, PD4, PD5, PD6, PD18 and PD19.

Section 3. This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of three-fourths (3/4ths) of the members of the corporate authorities of the City of Urbana, Illinois, then holding office.

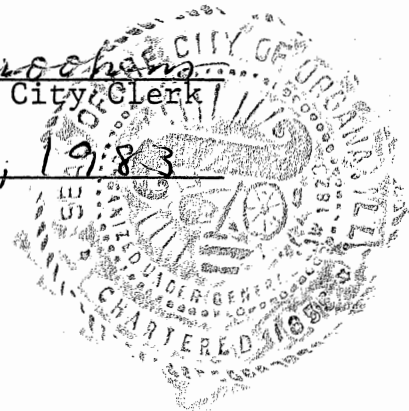
