AMENDMENT TO A PART OF THE ZONING ORDINANCE  
OF THE CITY OF URBANA, ILLINOIS  
AND THE ZONING MAP OF URBANA, ILLINOIS

WHEREAS, after due notice by publication, a public hearing was held on the 21st day of July, 1983, concerning the Petition filed in Plan Commission Case #1157-M-83, and

WHEREAS, the Urbana Plan Commission recommended approval of the request that the property herein described below be changed from B-1 Neighborhood Business to R-5 Medium High Density Multiple Family Residential.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that:

Section 1. The Zoning Ordinance of the City of Urbana and the Zoning Map of Urbana, Illinois, are herewith and hereby amended to amend the zoning classification of the following described area to that of: R-5 Medium High Density Multiple Family Residential

Lot 522 of Ennis Ridge 6th Subdivision to the City of Urbana, situated in Champaign County, Illinois, generally located on the east side of Vawter Street northeast of the intersection of Brighton Drive and Vawter Street, Urbana, Illinois. Said property bears the permanent index number 91-21-21-180-002.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 1st day of August, 1983.

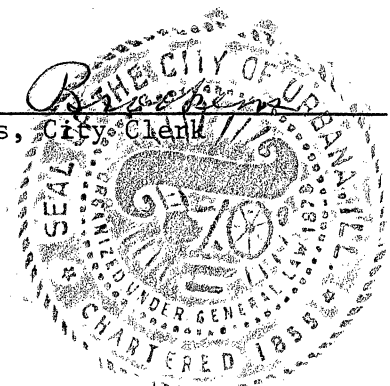

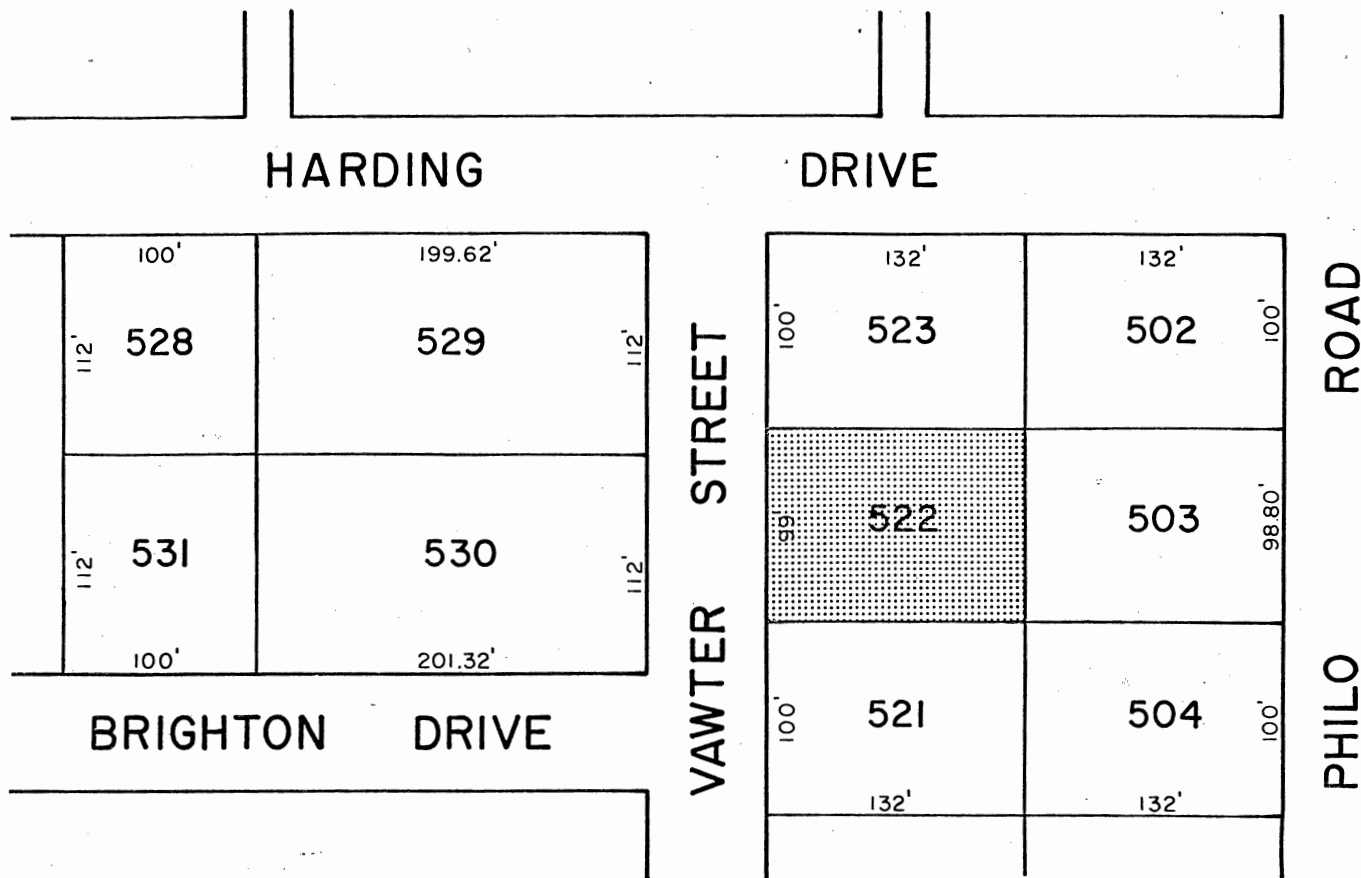
