

ORDINANCE NO. 8384-41

AN ORDINANCE
AMENDING SECTION 22-48 OF THE
CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS

WHEREAS, Section 22-48, entitled "Taxpayer's report", of the Code of Ordinances, City of Urbana, Illinois, establishes collection procedures for the City of Urbana utility tax; and

WHEREAS, it is in the best interest of the City of Urbana to receive its utility tax proceeds on a more timely basis.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Section 22-48, entitled "Taxpayer's report", of the Code of Ordinances, City of Urbana, Illinois, be and the same is hereby amended to read as follows:

(a) On or before the last day of March, 1984, each taxpayer shall make a return to the City Comptroller for the months of December, 1983, January and February, 1984, stating:

- (1) the name;
- (2) the place of business;
- (3) the gross receipts during that month upon the basis of which the tax is imposed;
- (4) amount of tax; and
- (5) such other reasonable and related information as the corporate authorities may require.

(b) On or before the last day of every month thereafter, each taxpayer shall make a like return to the City Comptroller for the month preceeding.

(c) The taxpayer making the return herein provided for shall, at the time of making such return, pay to the City Comptroller the amount of tax herein imposed; provided that in connection with any return the taxpayer may, if the taxpayer so elects, report and pay an amount based on the total billings of business subject to the tax during the period for which the return is made (exclusive of any amounts previously billed) with prompt adjustments of later payments based upon any differences between such billings and the taxable gross receipts.

Section 2. That the City Clerk of the City of Urbana, Illinois, be and the same is authorized and directed to send certified copies of this ordinance to:

Section 3. This ordinance shall be effective immediately upon its passage and approval as required by law. Nothing contained in this ordinance, however, shall be construed as affecting any of the provisions of the said Section 22-48 relating to the imposition and payment to the City of the total amount of tax otherwise imposed pursuant to Section 22-45 of the Code of Ordinances, City of Urbana, Illinois.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 19th day of March, 1984.

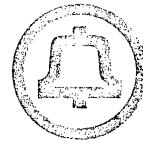
