AN AMENDMENT TO A PART OF THE ZONING ORDINANCE

WHEREAS, after due publication, a public hearing was held on the 9th day of August, 1984, concerning the Petition filed in Plan Commission Case #1181-M-84, and

WHEREAS, the Urbana Plan Commission recommended approval of the request that the property herein described below be changed from CRE Conservation/Recreation/Education to R-4 Medium Density Multiple Family Residential.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that:

The Zoning Ordinance of the City of Urbana and the Zoning Map of Urbana, Illinois, are herewith and hereby amended to amend the zoning classification of the following described area to that of: R-4 Medium Density Multiple Family Residential

All that part of the alley which lies west of and adjacent to Lots 4, 5, 6, 9, 10 and 13 of William Harvey's Addition to Urbana in Township 19 North, Range 9 East of the Third Principal Meridian, situated in Champaign County, Illinois,

commonly known as Webber School property, Urbana, Illinois.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the City Council of

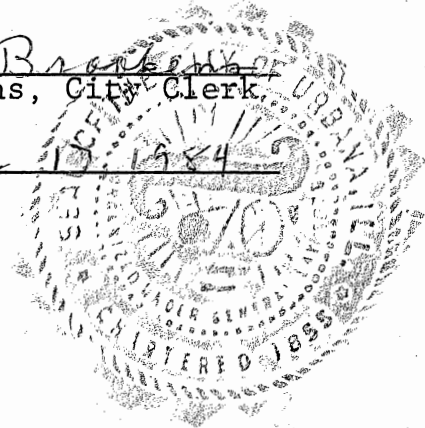
