

ORDINANCE NO. 8485-31

AN ORDINANCE  
APPROVING AN AMENDMENT TO AN AGREEMENT BETWEEN  
THE CITY OF URBANA AND LOCAL #1147 OF THE INTERNATIONAL  
ASSOCIATION OF FIREFIGHTERS, FOR THE TERM BEGINNING MARCH 1, 1983

WHEREAS, an Agreement between the City of Urbana, Illinois (the "City") and Local #1147 of the International Association of Firefighters, (the "Union") was duly entered into between the City and the Union on April 28, 1983; and

WHEREAS, Section 8.1 of the said Agreement provides that the said Agreement may be reopened for the purpose of negotiating salaries to be paid for the period July 1, 1984 through June 30, 1985, upon either party giving notice to the other in writing at least sixty (60) days prior to July 1, 1984; and

WHEREAS, notice as provided in Section 8.1 was duly given by the Union; and

WHEREAS, the duly authorized representatives of the City and the Union have met for the purpose of negotiating in good faith an Amendment to the Agreement for salaries to be paid for the period July 1, 1984 through June 30, 1985.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

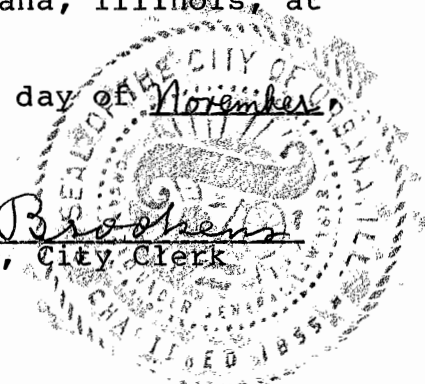
Section 1. That the Amendment to Agreement between the City of Urbana, Illinois and Local #1147 of the International Association of Firefighters, a copy of which said Amendment to Agreement is attached hereto and hereby incorporated by reference, be and the same is hereby approved.

Section 2. That the Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute and deliver and the City Clerk of the City of Urbana, Illinois, be and the same is hereby authorized to attest to said execution of said Amendment to Agreement for and on behalf of the City of Urbana, Illinois.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the City Council of the City of Urbana, Illinois, at a meeting of said Council.

AMENDMENT TO AGREEMENT

Pursuant to Section 8.1 of the Agreement between the City of Urbana and the Local #1147 of the International Association of Fire Fighters, dated April 28, 1983, the parties hereby amend said Agreement by adding the following to be effective for the period July 1, 1984 to June 30, 1985:

A. Section 8.1

Pursuant to said section providing that the Agreement may be reopened for the purpose of negotiating salaries for the period July 1, 1984 through June 30, 1985, the parties have agreed to the following:

1. The annual salary and hourly rate for each bargaining unit classification is to be increased by 4% as of July 1, 1984 (less \$121 Inspection Increase which is to be deleted. See 2 below) and by an additional 2% as of January 19, 1985, the new salary amount in each case to be computed based on the annual salary in effect as of June 30, 1984 and as listed in Appendix B of the current agreement.

2. In consideration of the deletion of the \$121 Inspection Increase the duties commensurate therewith will no longer be performed by Fire Fighters or Lieutenants commencing the date this Agreement is approved by the Urbana City Council.

B. Appendix B - Effective July 1, 1984 through and including January 18, 1985:

\*The base salary for probational employees as defined by Section 7.2 of

this Agreement shall, for the first six (6) months, of such employment, be \$2,400 less, and for the remaining six (6) months, be \$1,800 less than the annual base salary as established herein for a full-time uniformed Fire Fighter.

C. January 19, 1985 - June 30, 1985:

Lieutenant	24,086	8.272	11.580

\*The base salary for probational employees as defined by Section 7.2 of this Agreement shall, for the first six (6) months, of such employment, be \$2,400 less, and for the remaining six (6) months, be \$1,800 less than the annual base salary as established herein for a full-time uniformed Fire Fighter.
