

ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern-Prairie Fire Protection District and includes certain Highways within the Urbana Township and Somer Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees for Urbana Township and Somer Township, and the Township Commissioner of Highways for Urbana Township and Somer Township, said notices being mailed on July 19, 1984, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, August 6, 1984, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 27 day of July, 1984, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS:

Section 1. That the following described real estate, viz:

Commencing at the Northeast corner of Section 6, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois; thence Southerly 30 feet and Westerly 40 feet to the intersection of the West R.O.W. line of Lincoln Avenue and the Southerly R.O.W. line of Wilbur Road, thence Westerly along the South R.O.W. line of Wilbur Road 1584.09 feet to a true point of beginning; thence Southerly 802.85 feet, thence Westerly 794 feet to the East R.O.W. line of Oak Street, thence N 26° 07' 34" E along the East R.O.W. line of Oak Street 893.11 feet to the South R.O.W. line of Wilbur Road, thence Easterly 402.46 feet to the point of beginning containing 11.03 acres, more or less; and all the adjacent R.O.W. known as Oak Street and Wilbur Road, to wit: the entire 50-foot width of Oak Street south of the Somer Township line and the entire width of Wilbur Road up to 30 feet north of the Somer Township line, containing 1.62 acres; said tract encompassing a total of 12.65 acres more or less, situated in Champaign County, Illinois,

commonly known as southeast corner of Oak Street and Wilbur Road, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-06-201-001, and following annexation the said parcel shall bear the permanent index number 91-21-06-201-001.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the

City of Urbana, Illinois, at a regular meeting of said Council on the 6th  
day of August, A.D. 1984.

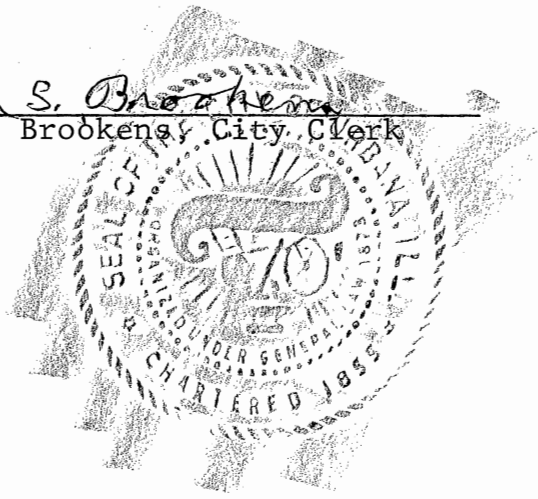
