

ORDINANCE NO. 8485-93

AN ORDINANCE NAMING ADDITIONAL PRIVATE STREETS WITHIN
THE WILLOW SPRINGS PLANNED UNIT DEVELOPMENT

WHEREAS, Willow Springs Planned Unit Development, a planned unit development approved under the authority of Champaign County, contains a number of private streets, and

WHEREAS, in Ordinance 8182-6 entitled, "An Ordinance Naming Streets Within Willow Springs Planned Unit Development," the Urbana City Council has already given names to private streets within the said planned unit development pursuant to the legal authority of the City of Urbana to exercise some control over the said planned unit development, and

WHEREAS, there have now been created further private streets that require names.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

1. That the private streets located within Willow Springs Planned Unit Development as designated on the attached map with the following names: "Clifford Drive", "Dean Drive" and "Richardson Drive", are hereby named as shown on the map attached hereto and incorporated herein by reference.

2. That the City Clerk is directed to furnish certified copy of this Ordinance to the Champaign County Clerk and the United States Postal Service branch office serving the area by certified or registered mail.

3. The street name signs designating the names of the streets as assigned herein shall be erected and maintained by the developer of the Willow Springs Planned Unit Development in accordance with the Illinois Manual on Uniform Traffic Control Devices. The street names herein assigned shall not

be considered as officially assigned until the street name signs are erected and approved by the City Engineer.

4. This Ordinance shall be effective upon its passage and approval by the Mayor.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 3rd day of June, 1985.

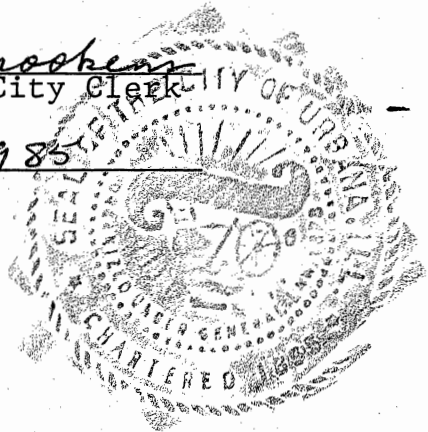
