WHEREAS, the Urbana Plan Commission has recommended the adoption of the following changes to the text of the Zoning Ordinance of the City of Urbana, Illinois.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that:

Section 1. The Urbana Zoning Ordinance is amended as follows: In the Article V, Table V-1, Table of Uses, within the category labeled Residential Uses, the following shall also be listed: Single Family and Duplex Uses, each being a separate entry.

Section 2. (a) The table shall also be amended to indicate that Single Family Dwelling shall be a permitted use in the following districts: AG, R-1, R-2, R-3, R-4, R-5, R-6, and R-6-B, and as a conditional use in the following districts: B-1 and B-2.

(b) Duplex use shall be permitted as of right in the following districts: R-3, R-4, R-5, R-6, and R-6-B, and shall be listed as a conditional use in the following districts: R-2 and B-1 and B-2.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.
