BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

That Article III, entitled "Smoking", of Chapter 11, entitled "Health and Sanitation", of the Code of Ordinances, City of Urbana, Illinois, be and the same is hereby amended as follows:

A. That Section 11-37, entitled "Responsibility of proprietors", be and the same is hereby amended to read as follows:

The proprietor or other person in charge of a public place covered by this article shall be responsible for the regulation of smoking in the public place by:

- (1) Conspicuously posting appropriate signs to identify such area designated pursuant to section 11-35 of this article as one where smoking is to be permitted or prohibited;
 - (2) Arranging seating to provide a smoke-free area;
- (3) Asking smokers to refrain from smoking in a nonsmoking area upon request of a client or employee suffering discomfort from the smoke; and
 - (4) Any other legal means which may be appropriate.
- B. That subsection (a) of Section 11-39, entitled "Penalties", be and the same is hereby amended to read as follows:
 - (a) Any person violating section 11-34 shall be fined ten dollars (\$10.00) for each such violation.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
