## ORDINANCE NO. 8586-66

AN ORDINANCE
PROVIDING FOR THE ADDITION OF CERTAIN
NAMED STATE ROUTES IN, OR ADJACENT TO,
THE CITY OF URBANA, ILLINOIS TO THE
MUNICIPAL STREET SYSTEM OF URBANA,
ILLINOIS

WHEREAS, the City of Urbana, in the County of Champaign and the State of Illinois, under date of \_\_\_\_\_, 198\_\_, entered into an Agreement with the State of Illinois which, among other commitments, provided for the transfer of jurisdiction of the following named State routes to the Urbana Municipal Street System:

- (a) FAS Route 524 from High Cross Road (FA Route 808) westerly 1.02 miles to the Urbana corporate limits.
- (b) FAU Route 7185 (Windsor Road) from the Urbana corporate limits westerly 0.47 mile to Philo Road (FAU Route 7185)
- (c) FAU Route 7185 (Philo Road) from Windsor Road (FAU Route 7185) northerly 1.70 miles to Cottage Grove Avenue.
- (d) FAU Route 7183 (Vine Street) from Main Street (FAU Route 7124) northerly 0.26 mile to University Avenue (US Route 150).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, as follows:

SECTION 1: That the following named routes be added to the Municipal Street System, upon final inspection by the State of the improvement set-forth in the aforementioned Agreement and the relocation of through traffic to the High Cross Road location

- (a) FAS Route 524 from High Cross Road (FA Route 808) westerly 1.02 miles to the Urbana corporate limits.
- (b) FAU Route 7185 (Windsor Road) from the Urbana corporate limits westerly 0.47 mile to Philo Road (FAU Route 7185).
- (c) FAU Route 7185 (Philo Road) from Windsor Road (FAU Route 7185) northerly 1.70 miles to Cottage Grove Avenue.
- (d) FAU Route 7183 (Vine Street) from Main Street (FAU Route 7124) northerly 0.26 mile to University Avenue (US Route 150).

SECTION 2: This Ordinance does not include the transfer of the structure known as State Structure No. 0222 carrying Vine Street over Boneyard Ditch south of University Avenue.

SECTION 3: Any and all previous ordinances in conflict herewith are hereby declared void.

SECTION 4: This ordinance shall take full effect from and after its passage, signing, recording, and publication pursuant to law.
