

ORDINANCE NO. 8586-97

ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notices being mailed on May 29, 1986, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, June 16, 1986, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 4th day of June, 1986, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,  
ILLINOIS:

Section 1. That the following described real estate, viz:

The East Half of the North Third of the following property taken as a Tract: Lots 6 to 11, both inclusive, of a subdivision of the West Half of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, in Champaign County, Illinois, and

The East Half of the South Half of the North Two Thirds of the following property taken as a Tract: Lots 6 to 11, both inclusive of a subdivision of the West Half of the Northwest Quarter of

Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, in Champaign County, Illinois, and

The East Half of the South One Third of the following property taken as a Tract: Lots 6 to 11, both inclusive of a subdivision of the West Half of the Northwest Quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, except that portion lying South of the North line of the County Road as described in dedication of right-of-way dated June 21, 1945 and filed August 14, 1945 in Book 267 at Page 431; Encompassing 14.72 Acres, more or less, situated in Champaign County, Illinois,

commonly known for reference as 1002 East Kerr Avenue, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index numbers 30-21-09-103-009 and 30-21-09-103-010, and following annexation the said parcel will bear the permanent index number 91-21-09-103-009 and 91-21-09-103-010.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

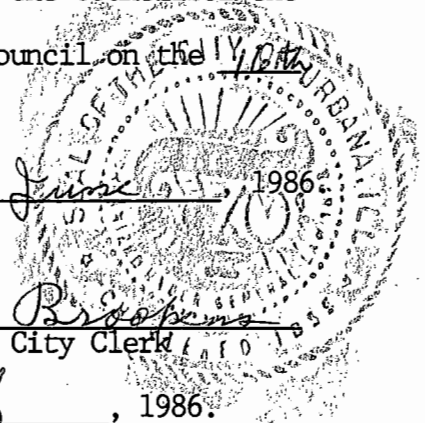
