ORDINANCE NO. 8687-33

AN ORDINANCE

ASSIGNING LANDFILL SITE OPTION TO THE INTERGOVERNMENTAL SOLID WASTE DISPOSAL ASSOCIATION

WHEREAS, the City of Urbana, Illinois ("Urbana"), the City of Champaign, Illinois and the County of Champaign, Illinois have entered into an Agreement and General Plan for Development of Solid Waste Disposal Facilities and Programs and the Creation of the Intergovernmental Solid Waste Disposal Association [(the "Association")] dated July 22, 1986 (the "Agreement"); and

WHEREAS, preliminary to and in connection with the Agreement Urbana acquired a certain option pursuant to a Solid Waste Disposal Facilities Real Estate Option and Contract by and between Urbana and certain property owners, as follows (the "Option"): Clara A. Dunn and Nancy L. Flach; and

WHEREAS, Section 2.2 of the Agreement requires Urbana to assign the Options to the Association in order to implement the terms and provisions of the Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the Option above described entered into by Urbana is hereby ratified, confirmed and approved.

Section 2. That Urbana shall and does hereby assign the Option to the Association pursuant to and in accordance with the Agreement, subject to provision for payment to Urbana by the Association from funds to be made available for such purpose at the times and in the manner set forth in the Agreement of the costs and expenses, including its attorneys fees, of obtaining the Option.

Section 3. That the Mayor be and is hereby authorized to execute and deliver one or more appropriate assignment instruments, to the extent desirable or necessary, to effect the assignment provided for in this Ordinance of the Option to the Association, the intent hereof being that no further instrument is necessary and that this Ordinance is sufficient therefor.

Section 4. That from and after the adoption of this Ordinance the Mayor, Clerk, and other appropriate officers, and each of them, hereby are authorized and directed to execute all documents and instruments and to do any and all things necessary to effect the assignments made under and pursuant to this Ordinance, and the performance of all other acts desirable or necessary to effect and carry out the authority conferred by this Ordinance.

Section 5. That this Ordinance shall become effective immediately upon its passage and approval.

This Ordinance is hereby passed by the affirmative voate, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the <u>lot</u> day of <u>Ordinal</u> 1986.
