AN ORDINANCE AMENDING SECTION 24-16 OF THE URBANA CITY CODE RELATING TO SEWER USE CHARGES

BE IT ORDAINED BY THE URBANA CITY COUNCIL, that:

Section 24-16 entitled "Sewer Use Charges" of the Urbana City Code is hereby amended in the following respects:

Section 1. All of the definitions in 24-16(a) are hereby repealed and in their place is enacted the following:

- "(1) Taxable unit. Any lot, tract or parcel having a building or structure, including a mobile home or modular home, which lot, tract or parcel has water metered service to any building or structure on such lot, tract or parcel.
- (2) Statement date. The date the charges made under this section are deposited in the United States Mail by the comptroller for the city.
- (3) Billed water usage. The average daily amount of water indicated as used by a taxable unit as determined from the records of the Northern Illinois Water Corporation or its successor for one selected actual or estimated water meter reading for such taxable unit during the months of January, February and March immediately preceding the statement date."

Section 2. All of 24-16(b) entitled "Determination of Unit Category" is hereby repealed and in its place is enacted the following:

"(b) Taxable unit charge. Each taxable unit shall pay an amount determined through the following formula, based upon the billed water usage of such taxable unit. The amount may be amended annually on January 1st. An actual or estimated water meter usage may be adjusted by the comptroller to exclude water furnished to the taxable unit which was evaporated or bottled for shipment in a commercial or industrial operation; or, to an amount which more properly represents an average annual actual figure, upon presentation of factual evidence by the property owner. Responsibility for initiating this review and presentation of this factual evidence rests entirely with the property owner. This evidence must be presented to the comptroller prior to April 15th of each year to be included in the billing formula for that year.

 $a = b \times c$

- a = Amount of tax on subject taxable unit.
- b = Billed water usage expressed in cubic feet.
- c = The sum of \$1.12 per cubic foot, or prorata portion thereof.

Provided, however, 20% of the funds collected pursuant to this section may be designated for the operation and maintenance of the sanitary sewer system of the city and those funds shall not be available for any other purpose."

Section 3. All of subsections (c), (d), and (e) of Section 24-16 of the Urbana City Code are hereby repealed and these subsections are re-lettered as follows:

(f) entitled "Billing." is changed to (c);

(g) entitled "Delinquent charges." is changed to (d);

(h) entitled "Responsibilities of property owner, city." is changed to (e);

(i) entitled "Use of funds." is changed to (f).

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.
