

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern-Prairie Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notices being mailed on December 2, 1986, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, December 15, 1986, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 9th day of December, 1986, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS:

Section 1. That the following described real estate, viz:

The South Half (S-1/2) of the North Eighty-two and Ninety-two Hundredths (82.92) feet of the South Five Hundred Eighty and forty-four Hundredths (580.44) feet of the Southwest Quarter (SW-1/4) of the Northwest Quarter (NW-1/4) of the Northwest Quarter (NW-1/4) of Section Eight (8); Except the East Eight (8) rods thereof, in Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois, also

The North Eighty-two and Ninety-two Hundredths (82.92) feet of the South Four Hundred Ninety-seven and Fifty-two Hundredths (497.52) feet of the Southwest Quarter (SW-1/4) of the Northwest Quarter (NW-1/4) of the Northwest Quarter (NW-1/4) of Section Eight (8) except the East Eight (8) Rods thereof, in Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, in Champaign County, Illinois,

Excluding the West 33 feet of the above described tracts, being part of the previously annexed Lincoln Avenue right-of-way; encompassing 1.41 Acres, more or less,

commonly known for reference as 1310 North Lincoln Avenue, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-08-101-003, and following annexation the said parcel will bear the permanent index number 91-21-08-101-003.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 15th day of December, 1986.

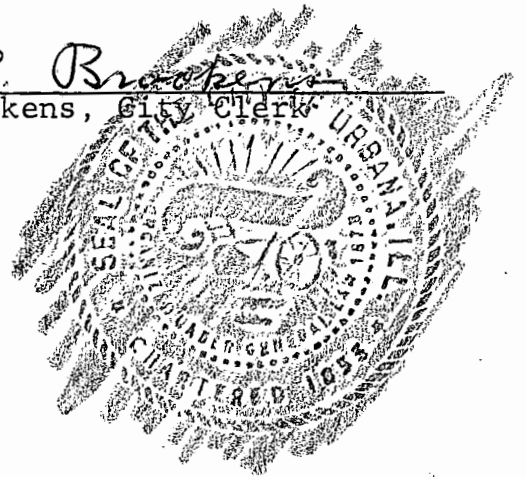
