

ORDINANCE NO. 8687-66

AN ORDINANCE  
DIRECTING THE CITY CLERK  
TO PUBLISH LEGAL NOTICE REGARDING ANNEXATION

WHEREAS, Section 7-1-13 of the Illinois Municipal Code provides that unincorporated territory containing sixty (60) acres more or less may be annexed when the conditions set forth in that section are met; and

WHEREAS, previously in Ordinance 8687-53, the City of Urbana attempted to annex the following described territory but, because of an error in the legal description of said property, such attempt was faulty, and

WHEREAS, the territory described below is wholly bounded by the City of Urbana, and contains sixty (60) acres or less, and

WHEREAS, the City of Urbana is still desirous of annexing the said territory.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:


That the City Clerk is authorized and directed to cause a notice to be published in a newspaper of general circulation within the territory to be annexed as required by the aforesaid statute so that the Urbana City Council may consider the annexation of the following described territory:


Beginning at the Northeast corner of the Plat of Survey filed for Record on March 16, 1983, in Plat Book Z, Page 243, as Document #83R3767 at the Office of the Recorder of Deeds, Champaign County, Illinois; thence S 87° 26' 48" E, 225.97' to the Northwest corner of a Tract described in a deed filed for record on December 17, 1975 in Record Book 1069, Page 505, as Document #75R18982 at the Office of Recorder of Deeds, Champaign County, Illinois; thence S. 02° 31' 50" W, 297.84' to the Southwest corner of said tract; thence N 87° 26' 59" W approximately 226.1', to the Southeast corner of the aforementioned plat of survey; thence N 02° 33' 12" E, 297.89' to the point of beginning situated in the South Half of Section 9, Township 19 North, Range 9 East of the 3rd Principal Meridian, Champaign County, Illinois, and encompassing 1.44 Acres, more or less,

at any time not less than ten (10) days after publication of such notice, to-wit on the 16th day of February, 1987.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council.
