

ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District and includes certain Highways within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on February 4, 1987, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, February 16, 1987, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 13th day of February, 1987, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS:

Section 1. That the following described real estate, viz:

Beginning at the Northwest Corner of the East Half of the Northeast Quarter of Section 9, Township 19 North, Range 9 East of the 3rd Principal Meridian; thence Easterly 376 feet; thence Southerly 547 feet; thence Easterly 119 feet; thence Southerly 926.9 feet; thence Westerly 400 feet; thence

Northerly 474 feet; thence Westerly 95 feet; thence Northerly 1000 feet to the point of beginning; encompassing 14.22 Acres, more or less, including a 376-foot by 20-foot portion of Perkins Road right-of-way, encompassing 0.17 Acres, more or less;

together with the adjacent portion of Perkins Road right-of-way lying north of this tract, further described as follows: Beginning at the Southwest corner of the Southeast Quarter of the Southeast Quarter of Section 4, Township 19 North, Range 9 East of the 3rd Principal Meridian; thence North 00° 13' 25" W 30 feet to the north right-of-way line of Perkins Road; thence North 90° 00' 00" East 85 feet along said right-of-way line; thence South 00° 13' 25" East 10 feet; thence South 90° 00' 00" East 150 feet; thence North 00° 13' 25" West 10 feet; thence North 90° 00' 00" East 141 feet; thence South 00° 13' 25" East 30 feet to the south line of said Section 4; thence South 90° 00' 00" West 376 feet to the point of beginning, encompassing 0.22 Acres, more or less;

all situated in Sections 4 and 9, Township 19 North, Range 9 East of the 3rd Principal Meridian, Champaign County, Illinois,

commonly known for reference as 1801 East Perkins Road, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-09-200-008, and following annexation the said parcel shall bear the permanent index number 91-21-09-200-008.

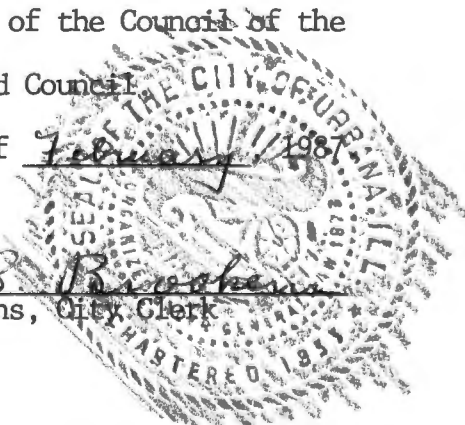
