ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and includes certain Highways within the Urbana Township, and Notice was given the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on February 4, 1987, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, February 16, 1987, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 13th day of February, 1987, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA,
ILLINOIS:

Section 1. That the following described real estate, viz:

Tracts 4, 5 and 6 of McCullough's Plat of Survey as filed in the office of Recorder of Champaign County as Document #71R-13121 in Book X of Plats, Page 38, encompassing 69.90 Acres, more or less, including the 50-foot by 500-foot portion of Windsor Road right-of-way at the North end of Tract 6, and also including the 30-foot by 270-foot portion of Race Street right-of-way at the west end of Tract 4, being 0.76 Acres, more or less, of included right-of-way;

together with the 20-foot by 270-foot portion of Race Street right-of-way west of and adjacent to said Tract 4, encompassing 0.12 Acres, more or less, situated in the Northwest Quarter of Section 29, Township 19 North, Range 9 East of the 3rd Principal Meridian;

all situated in Champaign County, Illinois,

commonly known for reference as a portion of Meadowbrook Park, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois.

The above-described parcel, prior to annexation, has the permanent index number 30-21-29-200-007, and following annexation the said parcel shall bear the permanent index number 93-21-29-200-007.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

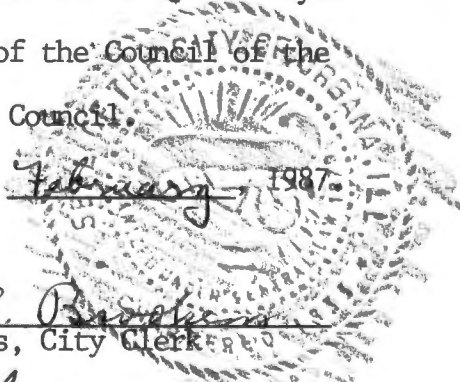
