## ORDINANCE NO. 8687-73



AN ORDINANCE ANNEXING AND REANNEXING CERTAIN PROPERTY

WHEREAS, in Ordinance #7475-18, enacted July 16, 1974, the following described property was purportedly annexed to the City of Urbana:

Beginning at the Southeast corner of the Northeast quarter of Section 9, Township 19 North, Range 9 East; thence Northerly along the East Section line of said Section 9 to the Center line of a drainage ditch also known as the Saline Ditch, thence Westerly 165 feet to an Iron pin; thence Northerly to the Southern most Right-of-Way line of FAI 74; thence Northwesterly along the Southernmost Right-of-Way line of FAI 74 to the point of intersection with the North line of said Section 9; thence Westerly along the North line of said Section 9 to a point 990 feet West of the Northeast corner of Section 9; thence Southerly to the center line of said Saline Ditch; thence Southwesterly along the center line of said Saline Ditch to the point of intersection of the North-South quarter section line to a point 627 feet South of the center of said Section 9; thence Easterly 1190 feet to iron pin; thence Northeasterly 1595 feet to the place of beginning, situated in Champaign County, Illinois,

and

WHEREAS, the said property purportedly annexed was mostly a portion of the sanitary landfill site owned by the City of Urbana, and

WHEREAS, the abovesaid legal description included property not actually owned by the City of Urbana at the time the annexation was passed and also inadvertently excluded minor portions of property owned by the City of Urbana that was intended to be included in said annexation ordinance, and

WHEREAS, it is desirable for the accuracy and continuity of public records that the discrepancies created by Ordinance 7475-18 be corrected as a matter of public record, and

WHEREAS, the above described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and may be part of the Carroll Fire Protection District and/or the Eastern-Prairie Fire Protection District, and includes certain Highways within the Urbana Township, and Notice was given to the Trustees of said Fire Protection Districts, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on March 3, 1987, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, March 16, 1987, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 10th day of March, 1987.

NOW THEREFORE, BE IT ORDAINED that the property described on the attached Exhibit "A" is hereby annexed and reannexed to the City of Urbana, Illinois. Said property is commonly known for reference as 1210 East University Avenue, Urbana, Illinois.
