

ORDINANCE NO. 8687-74

AN ORDINANCE
AMENDING THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Article VIII, Section 8-3, Schedule VIII of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by deleting from that schedule the following intersections where drivers of vehicles are required to yield:

Anderson Street Northbound at Elm Street
Maple Street Northbound at Elm Street
Maple Street Southbound at Elm Street
Urbana Avenue Northbound at Oregon Street
Urbana Avenue Southbound at Oregon Street
Lynn Street Northbound at Oregon Street
Lynn Street Southbound at Oregon Street
Johnson Avenue Southbound at Oregon Street
Wabash Avenue Northbound at Oregon Street

Section 2. That Schedule VII, entitled "Stop Signs Pursuant to Section 8-3", of Section 8-3, of Article VIII of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by adding to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersections:

Anderson Street Northbound at Elm Street
Maple Street Northbound at Elm Street
Maple Street Southbound at Elm Street
Urbana Avenue Northbound at Oregon Street
Urbana Avenue Southbound at Oregon Street
Lynn Street Northbound at Oregon Street
Lynn Street Southbound at Oregon Street
Johnson Avenue Southbound at Oregon Street
Wabash Avenue Northbound at Oregon Street

Section 3. That Schedule IX of Section 14-3, entitled "Parking Prohibited at all Times on Certain Streets", of Article XIV of the Urbana Local Traffic Ordinance, as amended, be and the same is hereby further amended by making modifications to that schedule indicating the following portions of streets where parking shall be prohibited at any time:

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Alley between High and Green Streets	Birch Street	McCullough Street	North and South

Section 4. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are, to the extent of such conflict, hereby repealed.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting.
