

ORDINANCE NO. 8687-86

AN ORDINANCE
AMENDING ARTICLE III, ENTITLED "NOXIOUS WEEDS", OF THE
CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS

WHEREAS, Ordinance No. 8687-65 was passed by the Urbana City Council on February 2, 1987, and approved by the Mayor on February 5, 1987, and as passed such ordinance inadvertently contained language that did not reflect the intention of the Urbana City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That §25-63(b) is hereby further amended to read as follows:
