

ORDINANCE NO. 8788-19

ORDINANCE ANNEXING CERTAIN TERRITORY  
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Philo Fire Protection District, and Notice was given to the Trustees of the said Fire Protection District, said Notices being mailed on July 23, 1987, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, August 3, 1987, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 28th day of July, 1987, and

WHEREAS, a written Petition signed by all of the owners of Record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana, and

WHEREAS, it has been determined that said Petition complies with all requirements of the law therefor, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

The East 1/2 of the NE 1/4 of Section 28, T. 19 N., R. 9E. of the 3rd P.M., EXCEPT the West 160' thereof, ALSO EXCEPT the following subdivisions as filed at the office of Recorder of Deeds of Champaign County: Myra Ridge First Subdivision, Book Y Page 222; Myra Ridge Second Subdivision, Book Z Page 30; Myra Ridge Third Subdivision, Book Z, Page 29; and Myra Ridge Fourth Subdivision, Book Z, Page 115; encompassing 31 Acres, more or less, situated in Champaign County, Illinois,

commonly known for reference as 2909 S. Susan Stone Drive, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-28-200-021, and following annexation the said parcel will bear the permanent index number 93-21-28-200-021.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

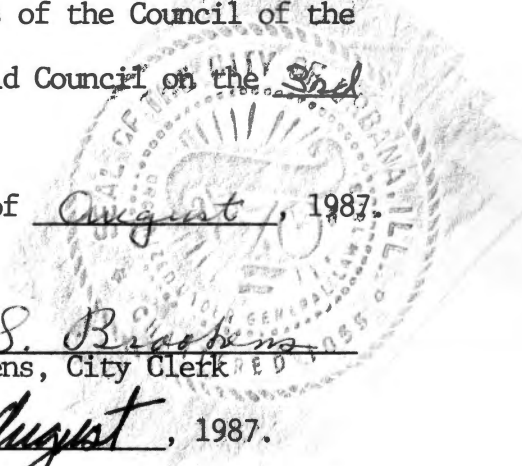
