

ORDINANCE NO. 8788-65ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern-Prairie Fire Protection District and includes certain Highways within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on April 20, 1988, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, May 2, 1988, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 25th day of April, 1988, and

WHEREAS, the City of Urbana, Illinois, is in fact the record owner of the subject parcel pursuant to Ordinance 7475-59 enacted January 6, 1975, and

WHEREAS, a written Petition signed by all of the interested parties (there being no electors residing therein) of all land within such territory, has been filed with the City Clerk of the City of Urbana, and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

Commencing at the northeast corner of the northeast 1/4 of Section 6, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois; thence north 90 degrees, 00 minutes, 00 seconds west along the north line of the northeast 1/4 of said Section 6, 2011.70 feet to the easterly right-of-way line of an existing public road running along the Illinois Central Railroad right-of-way; thence south 26 degrees, 07 minutes, 34 seconds west along the easterly right-of-way line of said existing public road, 926.52 feet for a true point of beginning; thence south 26 degrees, 07 minutes, 34 seconds west along the easterly right-of-way line of said existing road, 312.35 feet to a point being 25.58 feet north of the northerly line of the Wolohan Lumber Company tract; thence south 89 degrees, 59 minutes, 10 seconds east parallel with and 25.58 feet northerly from the north line of the Wolohan Lumber Company Tract, 438.92 feet; thence north 00 degrees, 43 minutes, 16 seconds west parallel with the westerly line of the Illinois Power Company Tract, 280.38 feet to the westerly extension of the northerly line of said Illinois Power Company Tract; thence north 89 degrees, 57 minutes, 54 seconds west along the westerly extension of the northerly line of said Illinois Power Company Tract, 297.85 feet, more or less, to the Point of Beginning, encompassing 2.37 acres, more or less; together with that portion of North Oak Street right-of-way immediately west of the above described tract, encompassing 0.40 acres, more or less; all situated in Section 6, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois,

commonly known for reference as 2508 North Oak Street, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-06-201-

004, and following annexation the said parcel shall bear the permanent index number 91-21-06-201-004.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from and after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 2nd day of May, 1988.
