

ORDINANCE NO. 8788-74

ORDINANCE ANNEXING CERTAIN TERRITORY

TO THE CITY OF URBANA

WHEREAS, the Council of the City of Urbana approved Ordinance No. 8788-64 authorizing the Mayor of Urbana to enter into an agreement to annex 13.57 acre tract generally known as 1000 East Anthony Drive, Urbana, Illinois on April 18, 1988; and

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District and includes certain highways within the Urbana Township, and within the jurisdiction of the Illinois Department of Transportation and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, and the Illinois Department of Transportation, said notices being mailed on May 26, 1988, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 P.M., Monday, June 6, 1988, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois on the 27th day of May, 1988; and

WHEREAS, a written petition signed by all of the owners of record of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, in compliance with the previously approved Annexation Agreement, requesting annexation thereof to the City of Urbana; and

WHEREAS, it has been determined that said petition complies with all requirements of the law; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the People of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

That part of the south half of the south half of the northwest quarter of Section 4 in Township 19 North, Range 9 East of the Third Principal Meridian, lying east of Willow Road, north of Interstate 74 and west of U.S. Route 45, except the one-acre tract at the southwest corner of the northwest quarter of said Section 4, extending 208 feet east of the center of Willow Road along a line parallel with the south line of said northwest quarter, and extending 248 feet north of the north right-of-way line of Interstate 74 along a line parallel with the west line of said Section 4, encompassing 13.57 acres, more or less, (tax parcel #30-21-04-100-003); and Together with the adjacent approximately 333' x 50' portion of Willow Road right-of-way and the adjacent approximately 150' x 320' portion of U.S. Route 45 right-of-way, encompassing 1.48 acres, more or less, all situated in Champaign County, Illinois.

Also known for reference as 1000 East Anthony Drive, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois.

Section 2. That the City Clerk be authorized and directed to file for record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from and after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the Members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 6th day of June, 1988.
