WHEREAS, the City records indicate the correct zoning classification of the property is R-5 Medium High Density Multiple-Family Residential; and

WHEREAS, said petition requests a correction of the Official Zoning Map to reflect the R-5 zoning classification of the subject property; and

WHEREAS, the Urbana Plan Commission recommended approval of the request that the Official Zoning Map of the City of Urbana be corrected to change the zoning classification of the property herein described below from R-3 Single- and Two-Family Residential to R-5 Medium High Density Multiple-Family Residential.

and for reference commonly known as 2017 Philo Road, 2018 Fletcher Street, 1401 Silver Street and 1305 Silver Street, Urbana, Illinois. The permanent parcel numbers are 93-21-21-183-001, 93-21-21-183-002, 93-21-21-183-003, 93-21-21-183-004.

The said area above described being represented on the map attached hereto and incorporated by reference.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.
