

ORDINANCE NO. 8889-31ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern Prairie Fire Protection District and includes certain highways within the Urbana Township, and notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on October 27, 1988, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, November 7, 1988, and the affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the 3rd day of November, 1988; and

WHEREAS, a written petition signed by all of the owners of record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City,

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

Lots 1, 2 and 3 of Harry Gill Second Subdivision, located in Section 5, Township 19 North, Range 9 East of the Third Principal Meridian, Champaign County, Illinois, said Subdivision containing 11.35 acres, more or less, as described in Plat of Harry Gill Second Subdivision duly recorded in Plat Book 2, Page 244 on March 17, 1983 in the Champaign County Recorder's Office;

Together with the adjacent portion of Interstate 74 right-of-way, encompassing 4.09 acres, more or less, and the adjacent portion of N. Willow Road right-of-way, encompassing 0.45 acres, more or less, all situated in Champaign County, Illinois.

commonly known for reference as Harry Gill Second Subdivision, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the permanent index number 30-21-05-277-001, 30-21-05-277-002 and 30-21-05-277-003, and following annexation the said parcels shall bear the permanent index numbers 91-21-05-277-001, 91-21-05-277-002 and 91-21-05-277-003 respectively.

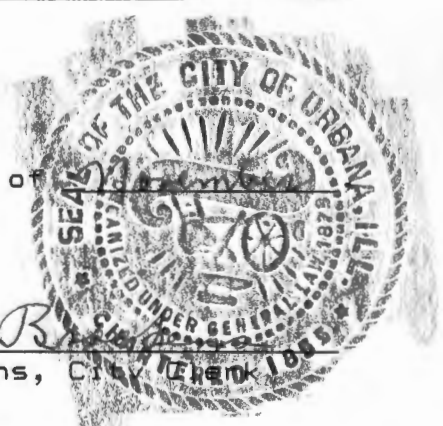
