

ORDINANCE NO. 8889-63ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern Prairie Fire Protection District and includes certain highways within the Urbana Township, and notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on February 23, 1989, that this Ordinance would be voted upon at the regular meeting of this Council on Monday, March 6, 1989 at 7:30 p.m., and the Affidavit of mailing such notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the 28 day of February, 1989; and

WHEREAS, a written petition signed by all of the owners of record and all electors residing therein, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

Tract 1: The West 1/2 of the North 495 feet of the Southwest Quarter of the Northeast Quarter of Section 5, Township 19 North, Range 9 East of the Third Principal Meridian, encompassing 7.53 acres, more or less, situated in Champaign County, Illinois; and

Tract 2: The East 1/2 of the North 495 feet of the Southwest Quarter of the Northeast Quarter of Section 5, Township 19 North, Range 9 East of the Third Principal Meridian, encompassing 7.53 acres, more or less, situated in Champaign County, Illinois; and

Tract 3: The North 486.74 feet of the Southeast Quarter of the Northeast Quarter of Section 5, Township 19 North, Range 9 East of the Third Principal Meridian, except the East 30 feet thereof, which is public right-of-way

commonly known as Willow Road, encompassing 14.41 acres, more or less, situated in Champaign County, Illinois. Together with the adjacent 486.74 feet by approximately 60 feet portion of North Willow Road right-of-way, encompassing .67 acres, more or less, all situated in Champaign, County, Illinois,

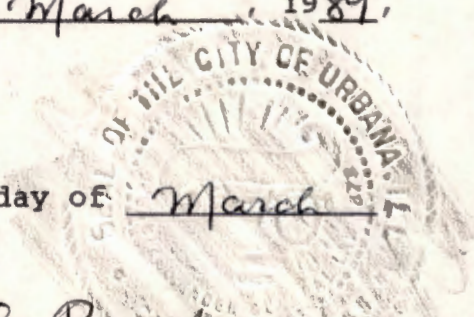
commonly known for reference as 2401 North Willow Road, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcels, prior to annexation, have the permanent index numbers 30-21-05-251-001, 30-21-05-251-002, 30-21-05-276-001, and following annexation the said parcels shall bear the permanent index numbers 91-21-05-251-001, 91-21-05-251-002, 91-21-05-276-001.

Section 2. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the Recorder of Deeds for Champaign County, Illinois.

Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 6th day of March, 1989, A.D.

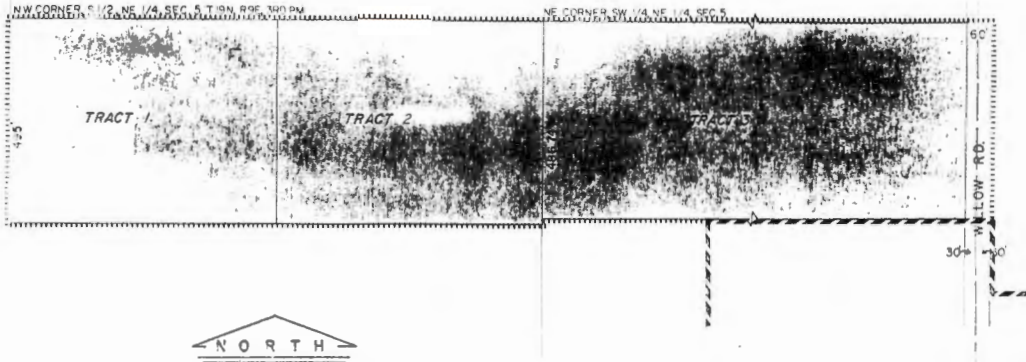
