and for reference commonly known as 903 W. Wascher St. (PC#1326-M-89), 905 W. Wascher St. (PC#1327-M-89) and 907 W. Wascher St. (PC#1328-M-89) respectively and Permanent Parcel Nos. 91-21-07-282-005, 91-21-07-282-004 and 91-21-07-282-003, respectively.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

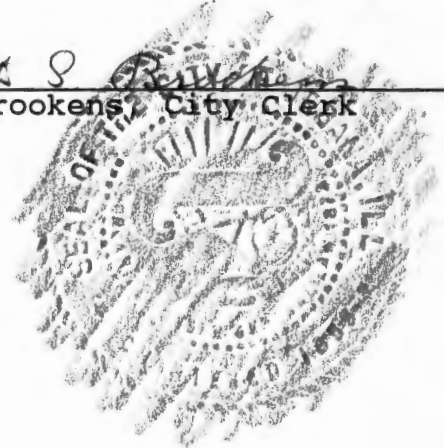

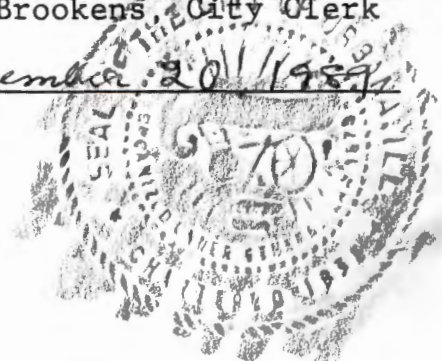
