

ORDINANCE NO. 8990-50

AN AMENDMENT TO ARTICLE XII

OF THE ZONING ORDINANCE OF URBANA, ILLINOIS  
(Extension of Downtown to Campus Interim Development District).

WHEREAS, the City of Urbana Zoning Administrator has submitted a petition to amend the text of the Zoning Ordinance of the City of Urbana; and

WHEREAS, said petition was presented to the Urbana Plan Commission as Plan Case #1331-T-89; and

WHEREAS, after due publication in accordance with Section XI-7, entitled Amendments of the Zoning Ordinance of the City of Urbana, and Chapter 24, Section 11-13-14 of the Illinois Revised Statutes, the Urbana Plan Commission held a public hearing on the proposed zoning amendment on November 9, 1989; and

WHEREAS, after due and proper consideration, the Urbana Plan Commission voted to recommend the adoption of the following change to the text of the Zoning Ordinance to the Urbana City Council; and

WHEREAS, after due and proper consideration, the Council of the City of Urbana has deemed it to be in the best interests of the City of Urbana to amend the text of the Zoning Ordinance of the City of Urbana, Illinois as described herein.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF URBANA, that the Zoning Ordinance of the City of Urbana, Illinois is amended as follows:

Section 1. The date of December 1, 1989 which appears in Article XII-4 entitled "Duration of Interim Development District" is hereby repealed and in its place is enacted the date of March 1, 1990.

The City Council hereby directs the City Clerk to publish this Ordinance in pamphlet form on November 21, 1989.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called of a majority of the members of the City Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 20th day of November, 1989.
