

ORDINANCE NO. 8990-102

AN ORDINANCE

APPROVING AND CAUSING PUBLICATION

OF THE OFFICIAL ZONING MAP

WHEREAS, the Illinois Municipal Code requires the Council to cause to be published each year a map showing the existing zoning uses, divisions, restrictions and classifications for the preceding calendar year and the map so published shall be the Official Zoning Map; and

WHEREAS, the City Council of the City of Urbana last approved an Official Zoning Map on March 20, 1989 in Ordinance No. 8889-67; and

WHEREAS, there have been annexations and zoning map amendments in the City of Urbana since March 20, 1989 and, therefore, the Official Zoning Map showing only changes through March 20, 1989 may not be useful to the public.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the attached map entitled Official Zoning Map of Urbana, Illinois dated March 1990 be and the same is hereby approved as the Official Zoning Map of the City of Urbana, Illinois pursuant to Section 11-13-19 of the Illinois Municipal Code, and Section IV-3 of the Urbana Zoning Ordinance, which said map reflects the official zoning districts in the City of Urbana as of March 19, 1990.

Section 2. That the fee to be charged to any person desiring to purchase a full-sized copy of the above mentioned map shall be Five dollars (\$5.00) per map.

Section 3. That the City Clerk be and is hereby directed to publish a full-sized copy of the attached map and to make sufficient copies available in her office for inspection by and or purchase by the public.

Section 4. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
